The Jefferson County Consortium is made up of the unincorporated areas of Jefferson County, Alabama and 30 municipalities within the County. The Cities of Birmingham, Bessemer, and Hoover, Jefferson County, the West Jefferson, Argo and Summit are the only cities in the County not participating in the Consortium. Birmingham, Bessemer and Hoover are entitlement cities themselves.
 Proposed 2008 Substantial Amendment Budget
 The Jefferson County Commission, through its Office of Community Development (JCC-OCDD), will use funds to purchase and rehabilitate homes and residential properties that have been abandoned or foreclosed upon in order to sell, rent or redevelop such homes and properties. JCC-OCDD may allow the use of other federal or local government loan, grant, guarantee, tax credit or tax-exempt bond or rent subsidy programs which do not conflict with NSP rules and regulations.

 b. Administration - \$23,787.00
 c. Total grant amount - \$2,237,876.00



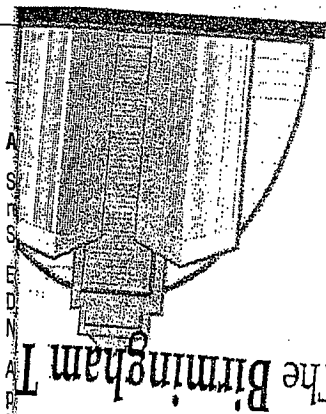
